I certify that, to the best of my knowledge and belief, I am in good health and in proper physical condition for the anticipated conditions of the 14th Annual Keller Cove Swim for Kids' Sake, and I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate. I understand and acknowledge the physical and mental rigors associated with open water swimming and realize that such events are inherently dangerous and represent an extreme test of a person's physical and mental limits. I understand and acknowledge that I may be exposed to extreme conditions and circumstances; hazardous natural or manmade objects; and dangers arising from adverse weather conditions, imperfect course conditions, water hazards including marine wildlife, situations beyond the immediate control of the event organizers, and other undefined harm or damage which may not be readily foreseeable; and other presently unknown risks and dangers. I understand that participation involves risks and dangers which include, without limitation, the potential for serious bodily injury, illness, permanent disability, paralysis and death. I understand that these risks may be caused in whole or in part by my own actions or inactions, the actions or inactions of others participating in the swim event, or the acts, inaction or negligence of the released parties. I voluntarily and knowingly recognize, accept and assume these risks. I agree to be familiar with and abide by the rules and regulations established for the 14th Annual Keller Cove Swim for Kids' Sake. I also accept sole responsibility for my own conduct and actions while participating in this swim event.

I understand and agree that this athletic event will test physical and mental limits and there is the possibility that I may suffer property loss, serious injury or death. This could be caused by the terrain, facilities, trail conditions and/or traffic on the roads and trails. This could also be caused by the actions of other people including but not limited to participants, volunteers, spectators, event producers, course monitors, members of Richmond Swims and East Bay Regional Park District employees, directors and or volunteers. I HEREBY FREELY AND VOLUNTARILY ASSUME ALL RISKS OF PARTICIPATING IN THIS EVENT.
